Cannabis Irrigation Policy

The cannabis policy establishes principles and guidelines (requirements) for cannabis cultivation activities to protect the domestic drinking water system and water quantity and quality issues that may arise as a result of cannabis cultivation and irrigation with domestic drinking water from the Lee Hammond MDWCA.

Cannabis irrigation by water from the Lee Hammond Water system is allowed with the following stipulations:

1. All cannabis irrigation with system water will be disclosed to the system and is limited to 200 mature plants.
2. All use of system water to irrigate cannabis will be done indoors or in greenhouses. No open fields will be allowed to use system water.
3. Above disclosure will be on our required form and will be kept up to date with ownership, water requested, and must be updated at least annually for approval by the board of directors of the system.
4. The system will provide a letter for the state showing the number of gallons allotted for use by the irrigator per month.
5. The irrigator will stay within the limits provided for in the above letter.
6. The rights to irrigate with system water may be curtailed because of drought or other natural disaster or incident that reduces the capacity of the water system to supply enough water to meet the needs of the members of the water system.
7. Irrigation / Commercial rights to use the water come second to the domestic drinking water needs of the membership.
8. If the irrigator asks for more than 2 acre feet of water per year, they will need to provide for those water rights with donations of water rights or the equivalent to the system. That may entitle the irrigator to a better water rate as well as a more secure water resource.
9. The system has sufficient water rights to provide such water.
